What is Millie's Mark?

As a parent, placing your child in an early years setting that is endorsed with Millie's Mark provides reassurance that all childcare practitioners know what to do in a paediatric first aid situation.

It acknowledges that children's safety is at the forefront of the setting's mind when they care for your child.

The National Minimum Standards for Regulated Childcare (NMS), which all registered childcare providers in Wales are required to follow, currently states that:

Within day care it is a minimum requirement for at least 1:10 (trained adult: child ratio) to hold a current Full Paediatric First Aid 12 hours certificate and all other staff (including regular volunteers or trainees) included in the adult: child staff ratios must undertake Emergency Paediatric First Aid 6 hours training and maintain a current certificate (NMS 10.24 & 10.25)

Millie's Mark is a special endorsement for childcare providers that go above and beyond these minimum requirements, ensuring that as well as having 100% of childcare practitioners trained in paediatric first aid, everything learned during the course is kept in the forefront of practitioners' minds so that they are confident, ready and capable.

Millie's Mark is named after Millie Thompson, who died after choking on food at nursery in 2012 when she was just nine months old. Read more about Millie's legacy at www.milliesmark.com/about-us. National Day Nurseries Association (NDNA) delivers Millie'sMark in conjunction with Millie's Trust.

How does an early years setting achieve Millie's Mark?

In order to apply for Millie's Mark, 100% of childcare practitioners working directly with the children must be qualified in paediatric first aid. The accreditation process takes between three and six months.

The process involves the setting checking processes and procedures meet the required standards through a setting audit, childcare practitioners confidence audit, childcare practitioners training matrix and floor plan review.

Once these steps are complete, nurseries upload evidence to the Millie's Mark website. The evidence is assessed by a panel attended by representatives from Millie's Trust and NDNA. A percentage of nurseries receive a spot check.

Sut mae darpariaeth blynyddoedd cynnar yn cyflawni Millie's Mark?

Er mwyn gwneud cais am Millie's Mark, rhaid i 100% o'r ymarferwyr gofal plant sy'n gweithio'n uniongyrchol gyda'r plant fod â chymwysterau cymorth cyntaf pediatrig. Mae'r broses achredu yn cymryd rhwng tri a chwe mis.

Mae'r broses yn cynnwys y lleoliad yn gwirio bod prosesau a gweithdrefnau yn bodloni'r safonau gofynnol trwy archwiliad lleoliad, archwiliad hyder ymarferwyr gofal plant, matrices hyfforddi ymarferwyr gofal plant ac adolygiad o gynllun llawr yr adeilad.
